# SOFTWARE UPDATE NOTIFICATION (SUN) – PEAQ-DSC SOFTWARE v1.30: PSW0005-04



## Introduction

This document details the PEAQ-DSC Software. Installation instructions and PC requirements are provided.

## Installation

It is assumed that you have authority to install software within your facility. It is also assumed that you have Administrator rights for the system upon which the software is installed, as this is a requirement of the installation process. If you do not have this authority, please consult with your IT support department before proceeding.

## **Recommended System Requirements**

The minimum requirements for running this software are highlighted in Table 1 below. Although the software can run using Windows 7<sup>™</sup> (64-bit) or Windows 7<sup>™</sup> (32-bit), it has been tested under Windows 10<sup>™</sup> (64-bit). Windows 10 is therefore the preferred operating system.

## Supported Languages

The PEAQ-DSC Software is available as an English language application.

When the software is configured for offline mode (analyzing data only), regional settings can be set to any language. However, when the software is used for controlling the PEAQ-DSC instrument, regional settings must be set to English.



#### Installation Instructions

The software is supplied as a self-executing installer. Once downloaded, the installer must be run to set up the software. It is not necessary to uninstall a previous version of the software before running the installer.

If the software is being installed on a PC not connected to an instrument, a license key will be required to run the software. A license key can be exported from the software, on the PC running the instrument. Instructions can be found in "Exporting a license file" section from the Software overview in the PEAQ-DSC User Manual (MRK2316, MRK2318).

#### Uninstall Procedure

The software can be uninstalled using the standard Add/Remove feature in the Windows 'Control panel'.

# **Known Issues**

The following software issues are known to exist in the software, and will be investigated as part of a future release.

Issue	Work around	Reference
When connected to an instrument, the software requires its PC to have a decimal separator of '.', a digit grouping symbol of ',' and a negative symbol of '-'.	Set the PC's Regional Settings to EN-US. This can be found in the Windows 'Control panel'. NOTE: the system will be configured from the factory with EN-US settings.  The software may be run offline using the user's preferred regional settings. Offline mode is the default installed configuration.	Issue #3537
A very large measurement file (.dmes) may throw an 'out of memory' or 'invalid format' warning when attempting to load. The critical (.dmes) file size will vary for each PC due to different hardware but will be approximately 200 MB (~250 records, depending on scan rate and temperature range).	A measurement file (.dmes) should be no larger than ~150 MB (~200 records) to ensure the file can be properly saved and loaded by the software.  The user should be mindful of this when configuring sequences and targeting existing measurement files.	Issue #3789
A very large raw data file (.dscx) may throw an 'out of memory' or 'invalid format' warning when attempting to save. The critical (.dscx) file size will vary for each PC due to different hardware but will be approximately 25 hours of total scanning.	A sample's total duration of scan(s) should be no longer than ~25 hours to ensure the file can be properly saved.  There are safeguards in place to prevent this, but given the variability of the limit, the user should be mindful of this when configuring samples.	Issue #4700
When the Windows taskbar is set to autohide, maximizing the PEAQ-DSC software will prevent access to the taskbar.	Disable auto-hide of the taskbar.	Issue #2224
When Windows Themes service is disabled, the PEAQ-DSC software may render incorrectly.	Keep Windows Themes service enabled.	Issue #3183
Depending on how the system is stopped, the message instructing to clean manually, and saying "The system was scheduled to clean this", may not be accurate. (In some cases it was cleaned)	If you are unsure, clean the instrument from the Maintenance workspace.	Issue #4061
In rare instances, a measurement may be left as read-only after the completion of a sequence.	The read-only flagged can be toggled through the measurement's file properties dialog accessed through Windows Explorer.	Issue #4176
The help file may fail to launch if file associations are not intact for .htm files.	Ensure the user has a program (i.e. Internet Explorer) associated with .htm files.	Issue #4737
